CAPITAL GAIN AND BUSINESS LOSS ESTIMATES

CMP 2012 RESOURCE LIMITED PARTNERSHIP ("CMP 2012") AND CMP 2013 RESOURCE LIMITED PARTNERSHIP ("CMP 2013")

FOR THE 2014 TAX YEAR

December 02, 2014 - Capital gain and business loss estimates for the CMP 2012 and CMP 2013 limited partnerships for the 2014 tax year are listed below. These figures are per unit **estimates only** and may differ substantially from the final amounts reported on tax slips T5013/RL-15.

Due to their significant tax incentives, flow-through shares purchased inside a limited partnership carry a low (or zero) adjusted cost base. This results in a capital gain for unitholders should the general partner sell a flow-through share from inside the partnership. The general partner will, on occasion, decrease or eliminate a holding from inside the partnership in order to lock in gains, manage liquidity constraints, or mitigate the impact of deteriorating fundamentals for a particular investment.

CMP 2012 completed its tax-deferred rollover into Dynamic Managed Portfolios Ltd. on January 10, 2014. Unitholders received 60.4652 shares of DMP Resource Class for each partnership unit held. On the date of transfer, the net asset values for CMP 2012 and DMP Resource Class were \$514.75 per unit and \$8.51 per share, respectively. CMP 2012 was subsequently dissolved.
